### **Cupertino General Plan Amendment and Housing Element Update**

On **December 2, 2014, at 6:45 p.m.**, the Cupertino City Council will hold a Meeting to consider amendments to its General Plan, including the Housing Element and Heart of the City Specific Plan, and Municipal Code Amendments to conform with the General Plan. The ordinances involve Below Market Rate Housing, Density Bonuses, Parkland Dedications, and zoning changes to conform to the new General Plan. **Note that this item was originally scheduled for November 18, 2014 but will now be considered on December 2, 2014 at 6:45 p.m. at Cupertino Community Hall, 10350 Torre Avenue.** The City encourages everyone to participate in these matters of significant importance to Cupertino.

During this hearing, the Council will make decisions regarding Citywide development policies and parameters, including heights, densities, land uses, retail, commercial, industrial, and residential, including properties within the Heart of the City, Homestead, North Vallco, North De Anza, South De Anza, South Vallco Special Areas and the Vallco Shopping District. The Council will also consider prioritizing properties for housing to send to the State of California Department of Housing and Community Development.
